# WE TAKE YOUR PRIVACY SERIOUSLY

By sharing your data with us or allowing us to collect data from other organisations, you can trust that we will handle it responsibly and use it to further our mission. We strive to develop a better understanding of our clients through their personal data, which helps us make informed decisions, improve fundraising efficiency, and achieve our goals of developing young entrepreneurs, fostering leadership, strengthening the Tooting Works Centre as a community asset, and becoming thought leaders in entrepreneurship and leadership.

# **Opt-In Communication Policy**

Since May 2018, in compliance with the General Data Protection Regulation (GDPR), we have adopted an "opt-in only" communication policy. This means that we will only send marketing communications to individuals who have explicitly stated their consent to receive such communications through their preferred channels, including email, SMS, phone, or post.

# Purpose of Processing and Legal Basis

We will use the personal data we collect from you for the following purposes:

**Marketing:** Promoting the services we offer, sharing case studies, and performing statistical analysis to inform our supporters and young people about the support we provide.

**Consent:** We will seek consent from individuals before processing their data for the above purposes.

By opting in, you confirm your consent to Business Launchpad using your personal data for the aforementioned purposes and grant us permission to carry out the necessary actions and activities.

# **Legitimate Interests**

Business Launchpad may have legitimate interests in certain situations, including:

Fundraising purposes, where identities will remain anonymous.











Contractual reporting requirements.

Assessing eligibility.

# **Categories of Personal Data**

The GDPR defines "personal data" as any information relating to an identified or identifiable natural person. This includes data such as name, identification number, location data, and other factors specific to an individual's identity. Additionally, the GDPR identifies certain data as "special categories," which include racial or ethnic origin, political opinions, religious beliefs, genetic data, health data, and more.

# The GDPR classifies certain data as belonging to "special categories", as follows:

- Racial origin
- Ethnic origin
- Political opinions
- Religious beliefs
- Membership to a trade-union
- Genetic data
- Biometric data
- Health data
- Data concerning a natural person's sex life
- Sexual orientation; and
- Other

At Business Launchpad, we collect various categories of personal data, including:

- Name,
- Address,
- Criminal record information,
- Email address,
- Telephone number,
- Contract preferences,
- Date of birth, age
- Education,
- Gender,
- Disability,
- Racial and ethnic origin











# **Recipients of Personal Data**

Business Launchpad is responsible for ensuring the security of its data processing facilities and other information assets in relation to third parties. This procedure applies to all situations where third parties require access to any of Business Launchpad's data, including all of the following categories of external parties with whom Business Launchpad may have agreements in place:

- Service providers, including managed security service providers
- Clients and customers
- Outsourcing suppliers including: facilities, operations, IT systems, data collection and call centers
- Consultants
- Auditors
- Providers of IT systems and services
- Providers of cleaning, catering and other outsourced support services; and
- Temporary staff, including placement and other short-term appointments.

Business Launchpad is responsible for assessing associated third-party risks according to the category and level of risk involved.

# Transfers to the third-party and safeguarding

Business Launchpad is committed to ensuring that all personal information collected and processed is appropriate for the intended purpose(s) and does not infringe upon your privacy. We may share your personal data with third-party service providers who are contracted by us, ensuring that they securely handle and use your personal data solely for the contracted service. When the service need ends or the contract expires, the third party will dispose of all personal data in accordance with our procedures. We will never share your personal data with third parties without your consent unless required by law.

#### **Retention Period**

As data subjects, you have certain rights regarding your personal data, including:

Right to access personal information.

Right to withdraw consent.

Right to amend personal data.











Right to request permanent deletion of personal data.

Right to restrict processing.

Right to lodge an official complaint with the relevant authority.

# Right to Lodge a Complaint with a Supervisory Authority

As data subjects, you have the right to lodge an official complaint with the relevant authority if you believe your data protection rights have been violated.

# Cookies
